The application period for K-8 families applying for a tuition scholarship at St. Benedict Cathedral School for the 2018-2019 school year has opened. The income guidelines for 2018-2019 are listed below.

St. Benedict Cathedral School is an approved Indiana School Choice Scholarship participant. The Choice Scholarship is an award from the state in which the per student state funding is granted to the approved private or parochial school of your choice. We also can award tax credit scholarships (SGO's) and we have other scholarships available for our students from endowments and other generous donors who support Catholic education.

We look forward to helping you get the tuition support you need through these programs. Please return the application form to us as soon as possible so we can process your application and notify you of the scholarship amount that your child qualifies for. **In addition to this form, please include a copy of page 1 & 2 of your 2017 tax return showing your adjusted gross income (AGI).** Please note if you are receiving child support or other income not documented on your tax return, you must include the amount of payments received in 2017 on the application, along with documentation.
